Organization. The Institute was founded in 1962 to carry out a diverse, interdisciplinary program of research in the behavioral sciences. Closely integrated with the academic programs of the University, particularly in psychology, research and graduate training are considered a joint enterprise and the participation of graduate students is encouraged in all research programs.

Organizationally, the Institute reports to the Vice Chancellor for Advanced Studies and Research, but the policy of joint appointments of staff members in academic departments has been encouraged. The participation of regular faculty members in ongoing projects and in interdisciplinary teams has added to the posture of the organization to undertake a wide range of studies.

<u>Programs</u>. Although the principal function of the Institute is research, it also sponsors training activities, including the Research Training Program in Psychology related to Heart Disease, Stroke, and Cancer, and the TCU Management Seminar.

The areas of research pursued during the past few years reflect staff interests in both basic and applied scientific research on problems in personality, social behavior, aerospace psychology, personnel selection and training, health-related problems including illness behavior and narcotic addiction, mental health, management and organizational behavior, human ecology, and multivariate statistical analysis.

Facilities. The Institute is located in two buildings on the East Campus which together provide approximately 8,000 square feet of occupiable space. The main building is a handsome new Armco Steel, one-story structure, housing offices of the director, administrative staff, Multi-variate Behavioral Research, research staff members, programming staff, and the IBR Technical Library. The Annex is a refurbished World War II, frame building, scheduled to be replaced by an Armco Steel building, similar to the main building, in 1970. The Annex houses research staff, graduate research fellows, the Psychophysiology Laboratory, computing equipment, and secretarial offices. Document storage facilities are maintained in both buildings.

The IBR Technical Library has an extensive collection of over 2000 reference and text books in psychology and behavioral sciences, 40 journals, many complete back to the 1930's, Air Force, Army, Navy, NASA, and other Technical Report Series, and reprints. This library is used primarily by IBR staff and graduate students, but is available to the University community.

The Psychophysiology Laboratory consists of a shielded room equipped with a six-channel E & M Physiograph VI and special auxillary equipment for human psychophysiological research, and a control-observation room, the two separated by a one-way viewing window. Recording apparatus, for analog to digital computer conversion, are in the process of purchase and installation. Plans for computer terminals in the control-observation room are presently under consideration.

The Institute has equipment for key punching and verifying program and data card decks and an old IBM sorter, with bin counters. A Control Data G-15 computer has been used for experimental work, but is to be replaced by a solid state computer. Computations are carried out using IBM 1401, 1620, and 1800 computers on campus, the IBM 360 - 50 computer at the Southwest Center for Advanced Studies, Dallas, and other off-campus equipment, as needed. The extensive and well-documented IBR program library is maintained in the main building and is available to research workers without restriction.

<u>Publications</u>. The Institute maintains an IBR Technical Report Series, based on research completed under grants, contracts, and independent study by staff members and students. These are distributed to a regular mailing list and in most cases are condensed for more formal publication. A number of books published by the TCU Press and by IBR are distributed through the Institute. In addition, the journal, <u>Multivariate Behavioral Research</u>, published by the Society for Multivariate Experimental Psychology through the TCU Press, has its Business Office at IBR.
